- 5) Lt. Chuck Greulich from North Precinct provided a crime update and fielded questions & concerns. He has worked in Portland as a Police officer for 17 years and in April was promoted to Lieutenant. He reported we live in a very safe neighborhood without a lot of crime, similar to the Alameda, Grant and deep SW neighborhoods. Most guns committed in crimes have been stolen. There is a very small percent of people who are doing most of the shootings in Portland and the focus is on that group of people. There has been a pretty decent reduction on car thefts throughout the city. When asked about the shooting on 37th and Milton he was unable to give a lot of information as it is still an ongoing case but he did say that the victim was not from this area and it was not likely gang related.

- 1) Approval of Meeting Agenda: Patty moved, Gary seconded, approved unanimously
- 2) Approval of August 12th General Meeting minutes as amended: Karla moved, Susan seconded, approved unanimously
- 3) Treasurer's Report (Treasurer Karla Lenox)
 - a) Cash in checking account: \$29,942.24
 - b) Cash in Venmo Account: \$635.91
 - c) Outstanding Bills: \$2,234 for Newsletter with extra color (an increase of \$212). \$15.99 for Zoom bill payable to Gary.
 - d) Art and Garden final accounting. \$3,761 raised with a net of \$3,292. \$750 was donated to Vernon School's PTA and \$2,500 was slated to be donated to BMS's PTA. Al moved that the BMS donation be given to the BMS Beaumont Family Resiliency Fund, Patty seconded, the motion was passed unanimously.
